



**CALL FOR VISITING AT-RISK SCHOLARS**

**A.Y. 2021/2022**

**Application deadline: 2 pm (CEST, Italy) on April 22<sup>nd</sup> 2022**

**Art. 1 - Scope**

The University of Milan, in the framework of the initiatives promoted by the roundtable for "Reception and Integration in the University", as a member of the international network "[Scholars at Risk](#)" (SAR) and its Italian section SAR-Italia, and in view of the current international crisis in Ukraine and in other geographical areas, issues a call for applications for **4 positions of Visiting at-risk Scholar** financed by University's funds.

Further positions may be activated and/or co-financed by the Departments.

**Art. 2 - Requirements**

To be eligible, candidates must be Ukrainian citizens or other non-EU country nationals coming from areas where political and/or military crisis is underway and meet the following requirements:

**a)**

1. holds refugee status in Italy or a EU member state; or
2. is entitled to subsidiary protection in Italy or a EU member state; or
3. is seeking asylum or protection<sup>1</sup> in Italy or a EU member state; or
4. is entitled to temporary protection in Italy or a EU member state.

Candidates falling into one of the above categories shall include to their application evidence of: a) refugee / subsidiary protection status, or b) asylum or protection seeker status, or c) temporary protection status.

**b)** Being employed as a lecturer at a Ukrainian university or research institution or, alternatively, being qualified for university teaching, with documented work experience at international universities, research or public institutions.

**c)** Holding a Master's Degree.

**d)** Being proficient in English, French, Italian or Spanish according to the research, teaching or training activity requirements (see art.3, point 4).

**e)** Holding a PhD Degree is considered a preferential requirement

### Art. 3 - Application and Deadline

Applications shall be drawn up using the form attached hereto (Annex I), and sent to [international.visiting@unimi.it](mailto:international.visiting@unimi.it), with the following attachments:

- 1) self-certification of the requirements referred to in art. 2, a) (Annex II);
- 2) copy of an identity document/passport;
- 3) CV and publications;
- 4) programme of research, teaching or training activities to be carried out (Annex III);
- 5) a letter of acceptance from a Milan University Department signed by the Department Head or his/her deputy may be considered as a preferential requirement (Annex IV).

Applicants need not hand in a printed copy of the online application to the competent Office. Applications must be submitted **by 2 pm (CEST, Italy) on April 22<sup>nd</sup>**.

### Art. 4 - Duration of Stay and Compensation

The minimum period of stay is three months. The University shall pay the visiting at-risk scholar a gross all-inclusive fee of **€ 8,400**.

The selected Visiting Scholars may carry out training and/or seminar activities that shall be planned in concert with Departments and held during academic sessions by the end of the academic year (September 30, 2023).

The selected Visiting at-risk Scholars shall sign a letter of appointment by the University specifying his/her research, training and seminar activities, compensation and timeline.

The Visiting at-risk Scholars shall carry out support training and seminar activities, possibly as co-instructors.

**The aforementioned all-inclusive fee is gross of any withholdings and contributions to be paid by the recipient.** The compensation will be paid as a lump sum upon completion of the programme, following the submission of the *Activity Report* pursuant to art. 6.

Visiting at-risk Scholars from EU member states holding a European Health Insurance Card (EHIC) will enjoy health care during their stay in Italy. EU citizens without EHIC, as well as Scholars from non-EU countries, may access health care services provided they take out an insurance policy at their own expense.

Third-party liability shall be covered by the University insurance policy.

The entry to, and residence in, Italy of Visiting at-risk Scholars shall be governed by Italian national laws and local regulations.

### Art. 5 - Selection Process

Candidates will be selected by a special Committee appointed by the Rector based on the following criteria:

- scientific and academic profile (up to 12 points);
- programme of research, teaching or training activities to be carried out (up to 12 points);



- language proficiency, as (self-)certified (up to 6 points).

The results of the selection process will be announced by **May 15<sup>th</sup>, 2022**.

**Art. 6 - Reporting Requirement**

At the end of his/her stay, the Visiting Scholar shall produce an *Activity Report* using the *template* provided by the competent Office.
